

2018 SUMMIT COUNTY RESIDENTIAL PROPERTY TAX RATES

Multiply the market value of the home by the number listed below to determine the approximate Real Property Taxes in each community. This figure does not include any special assessment charges or delinquent taxes due. The tax year 2018 is payable in year 2019.

Example: Annual Taxes on a home in Bath Township/Revere LSD \$100,000 x 2.18% = \$2,180
